New York State Medicaid Recipient Restriction Program

Effective February 24, 2025, restriction edits supporting the Recipient Restriction Program (RRP) edits have been restored. As a result, a restricted recipient will be required to obtain all their care, directly or by referral, from their assigned providers.

In the event of an emergency, such as drug shortages, unexpected pharmacy closures, and/or unexpected travel, see the guidance below.

During regular business hours, a restricted recipient can obtain a temporary authorization to fill the prescription at an alternate pharmacy location by contacting:
