The FDA posted an Early Alert about a letter distributed by Abbott Diabetes Care to distributors, healthcare providers, and affected customers, recommending that certain FreeStyle Libre 3 and FreeStyle Libre 3 Plus sensors be removed from distribution or sale and that customers discontinue use.
- [NYRx Notice to Providers: Coverage Update Phosphate Binders/Regulators](#) – Effective January 1, 2026. Drugs in the Phosphate Binders/Regulators Preferred Drug List (PDL) class are no longer be covered as a pharmacy benefit by NYRx.

## New York State Department of Health Publications

- [Attention Pharmacy Providers: Changes to Coverage of Phosphate Binders for Patients on Dialysis](#) – Effective January 1, 2026. Phosphate binder drugs for patients on dialysis are no longer be covered as a pharmacy benefit by NYRx. Phosphate binders will be provided by the member's dialysis center.
- [Dental Policy and Procedure Code Manual](#) – Effective January 1, 2026. General policy guidance for use by dentists, dental staff, administrators, and billing agents to facilitate participation in the New York State Medicaid Dental Program.
- [Discontinued Drug Coverage for Terminated Labelers per Medicaid National Drug Rebate Agreement](#) – Effective January 1, 2026. NYRx will no longer provide coverage for drugs by manufacturers who voluntarily withdrew from participation in the Medicaid Drug Rebate Program (MDRP).
- [New Cost Optimization Program: Targets High-Cost Formulations / Dosages of Drug Products](#) – Effective December 18, 2025. NYRx is initiating a cost optimization program to help address increasing drug costs.

HCPCS codes have been updated to remove the word "hydrophilic" and HCPCS codes for hydrophilic coated intermittent urinary catheters have been added.
