

NYRx Electronic Prior Authorization via CoverMyMeds: Available Starting July 15, 2025

July 1, 2025

Electronic Prior Authorization Submission

Effective **July 15, 2025**, NYRx, the Medicaid Pharmacy Program, will accept electronic prior authorization (ePA) requests via CoverMyMeds® in addition to the current phone and fax submission methods.

CoverMyMeds streamlines the prior authorization process by guiding prescribers through required clinical questions, which can lead to real-time approval when clinical criteria are met.

Through this platform, prescribers will be able to:

- Submit prior authorizations electronically, with the opportunity for real-time approval if clinical criteria are met.
- Upload necessary supporting documentation.
- Track request status in real-time.

Additionally, pharmacy providers who utilize CoverMyMeds will have the opportunity to initiate medication ePA requests on behalf of the member for completion by the prescriber. CoverMyMeds will direct the case to the prescriber's queue and prompt them to complete and submit the ePA to NYRx.
