- Complex care coordination for populations such as HIV/AIDS, Hemophilia, Foster Care Children, Serious Mental Illness, Substance Use Disorder, and Hepatitis C

Changes to Over-the-Counter Medications

Starting August 1, 2025, NYRx will no longer cover the following over-the-counter items:

- Bismuth subsalicylate-containing products (Pepto-Bismol®)
- Carbamide peroxide-containing products (Debrox®)
- Menthol containing products (Bengay®, Icy Hot®)
