## **Option to Bill Additional Medical Supply Products**

Effective March 16, 2023, NYRx, the Medicaid Pharmacy Program, will expand the list of medical supplies that can be billed by the 11-digit National Drug Code (NDC). Alcohol pads, condoms, lancing devices for blood glucose testing, and spacers for metered dose inhalers are included in this update. This is an expansion to the notice sent February 17, 2023, titled, "Options to Billing Guidance for Select Syringe and Diabetic Supply Products." Medical and diabetic supplies reimbursable through NYRx are subject to the products listed on the Pharmacy List of Reimbursable Drugs found at: <a href="https://www.emedny.org/info/formfile.aspx">https://www.emedny.org/info/formfile.aspx</a>. Please refer to the "Medical Supplies" category found at NYRx's <a href="Information for Providers">Information for Providers</a> website for additional detail. <a href="Please note">Please note</a>, procedure code A4927 for gloves were included in a previous communication dated March 16, 2023 and have been removed.

The 11-digit NDC on the package dispensed must match the NDC billing code on the Pharmacy List of Reimbursable Drugs and the NDC submitted on the claim. In the event an NDC is not found on the list of reimbursable drugs, providers should continue to submit claims using the Healthcare Common Procedure Coding System (HCPCS) code found in the <a href="NYRx">NYRx</a>, <a href="Medical Supply Codes Billable by a Pharmacy">Medical Supply Codes Billable by a Pharmacy</a> document. Durable Medical Equipment (DME) procedure codes should be submitted in National Council for Prescription Drug Programs (NCPDP) field '407-D7' (Product/Service ID) using the 11-digit NDC format with leading zeros and qualified as a HCPCS code by submitting "09" in field '436-E1' (Product/Service ID Qualifier).

The Department will continue to consider adding select NDCs of <u>medical supplies and procedures</u> commonly billed by pharmacies.
