

## Pharmacy Provider Notice: NuvaRing® Coverage Change

The Centers for Medicare and Medicaid Services (CMS), in compliance with Social Security Law Sec. 1927 [42 U.S.C. 1396r–8] (a), requires drug manufacturers to participate in the Medicaid Drug Rebate Program (MDRP) for their drugs to be eligible for coverage under the Medicaid program.

Organon & Co., the original manufacturer of **NuvaRing®**, has out licensed this product to Advanz Pharma Corp. The new manufacturer, Advanz Pharma Corp, does not participate in the MDRP. **NuvaRing® manufactured by Advanz Pharma Corp. will not be reimbursed by NYRx**.

Providers may continue to utilize available stock supplied by Organon & Co. Please refer to the table below:

NuvaRing® manufactured by Organon & Co., remains included in the <a href="NYRx Brand Less than Generic program">NYRx Brand Less than Generic program</a> until the marketplace supply runs out. If a pharmacy is unable to obtain NuvaRing® supplied by Organon & Co. from their wholesaler, the NYRx Medicaid Pharmacy Program will allow for the generics to these products to adjudicate without prior authorization. Providers must counsel members regarding any change to medications dispensed.

**Note:** Members that chose to pay out of pocket for NuvaRing® manufactured by Advanz Pharma Corp. are **not** eligible for reimbursement. Refer to August 23, 2024, provider communication titled "Reminder: Pharmacy Providers Regarding Member Out-of-Pocket Costs"
